#### **Elections 2012 - Frequently Asked Questions**

#### What happens now that nominations have been submitted to the College?

- The Registrar will confirm receipt of the nomination with the nominee
- The Registrar will ask for a short bio from each nominee to include with the ballot mail out so that registrants can make an informed choice. Nominee & election information will also be posted on the College website

#### What is the election procedure?

- Ballots are prepared and sent to all full registrants and non-practising registrants for voting
- Ballots must be returned to the College office by the specified due date
- Each full registrant and non-practising registrant is entitled to one vote for each vacancy on the Board
- Ballots must be received in the form specified to be counted or will be considered spoiled
- Nominees receiving the most votes on the return of the ballots are elected to the Board

#### What are the terms of office?

- Term of office for an elected board member is 3 years, with an exception in 2010
- In 2010 there were three 2year terms and three 3year terms
- The maximum term of office is six consecutive years

#### **RECEIPTS FOR TREATMENT - Use your Legal Name**

The College continues to receive letters from third-party insurers who have been unable to confirm a practitioner's registration status. The problem is caused by registrants not having their legal name on the receipts. The CTCMA website is used by members of the public and others such as third-party insurers to confirm a practitioner's registration. Registrants should note that all practising registrants are listed, but only under their legal names. If registrants wish to include any additional names including English names, that information should be put in brackets.

## **Business Card Legal Name Reminder**
